B. Verbindliche Vorgaben

2. bei einer Unterrepräsentation von Frauen gemäß § 11 Abs. 2 Z 1 bis 3 B-GlBG ist gemäß § 11a Abs. 3 Z 1 bis 3 B-GlBG der Frauenanteil bis zum 1. Jänner 2008 um 5% und gemäß § 11a Abs. 2 B-GlBG bis zum 1. Jänner 2012 um weitere 10% anzuheben.
